We are proud to announce the launch of the North East England Climate Coalition (NEECCo) on Tuesday 30th March 2021.

What is NEECCo?

- We are a cross-sector coalition bringing the North East region together to tackle the climate emergency, to reverse ecological collapse and deliver a just transition. We aim to accelerate the movement towards zero emissions which, if achieved, will mean that the birthplace of climate change the North East of England will no longer be contributing emissions. We will instead become a leader in the response to the climate emergency.

Becoming England's Greenest Region

We will:

- Convey a positive vision of our Region that everyone people, communities and organisations in all our diversity can identify with.
- Adopt clear ambitious targets for our region that can be monitored and evaluated. "We commit to meet them and intend to beat them".
- Deliver climate and environmental initiatives that can only be accomplished regionally and by working together across sectors and organisations.
- Give clear added value to our partners regionally and locally, to increase their individual impact, and to support them to achieve more together.
- Attract new resources into the region, and attract national and international profile for our region's work.

What are our initial objectives?

- A greener, fairer, more efficient region, driving:
 - o Decarbonisation, and the achievement of a Net Zero target
 - o Clean growth, underpinned by innovation and good green jobs
 - o Environmental protection, restoration and enhancement
 - A Just Transition from the current carbon economy, that embeds a higher quality of life and equity, protects the most vulnerable, and improves workers' rights and livelihoods

Why are we working at a regional level?

- Our partners already have their own strategies for tackling the three challenges of climate emergency, ecological collapse and a just transition. NEECCo will not interfere in any way with these responsibilities and ambitions. But by working together we will strengthen the ability of each partner to deliver their own ambitions
- We will share examples of good practice across the region, to enable each of us to learn from our colleagues
- We will attract new resources into the region from Government, and from private and individual investment – by developing a "test-bed" offer, and by being seen as an effective region in which to bring about change
- We will support positive initiatives at scale that would benefit from regional mobilisation or endorsement to create local value and good jobs in the green transformation
- We will stimulate new cross-sector initiatives between partners
- We will harness the support of all in the community behind a move towards net zero, engaging all sections of society, and helping them discover what vital roles they can play as 3 individuals and collectively in improving our region











- We will listen to and engage all sections of society to ensure the green transformation is inclusive and equitable
- We will create a sense of pride in our region, through the leadership we intend to display.

Why should initiatives be piloted in the North East England? The North East:

- Is the smallest population English Region (affordability),
- is targeting becoming England's Greenest (ambition),
- has a mix of dense urban/industrial, coastal and rural communities (spatial diversity)
- has a Civil Society, deeply rooted in work with marginalised groups (reach)
- has an acknowledged track record of regional co-operation (believable delivery)
- is a 'left behind' region, vulnerable to the impacts of Covid and Brexit (in line with priorities)
- is the only English region with a positive balance of trade (economic contribution)
- already contains nationally important innovatory projects across technology, engineering, environmental restitution and addressing the social and economic consequences of an unjust transition (policy integration)
- is over a year into developing a multi-sector regionwide programme (self-help)
- has a history that connects directly to current climate challenges (a compelling narrative)

What do we plan to do?

- In June 2021 we will agree a new governance structure and resourcing structure for NEECCO. We are discussing with some of the key strategic partners what simple structure is most effective for agreeing decisions across the coalition a group that is small enough to drive action, whilst inclusive enough to engage the very wide current and future membership of NEECCo. We are also discussing options for resourcing NEECCo with key partners.
- In July 2021 we aim to publish a Draft Regional Plan, for wide consultation
 - For many months now we have had planning groups from across sectors working up proposals for how we might transform our work in the region. In July we will bring together this work into one document, with a range of delivery plans.
 - We have been working on a set of indicators for how we might measure our progress
 Becoming England's Greenest Region. We will establish a high-level evidence group to agree the measures we should best use, and to scrutinise our developing programme.
 - We will convene a major consultation summit, and other ways of canvassing views on our draft plans
- We will work with Government and our partners to develop options for "test-bed" trials within the North East.
- We will work with investors to develop a portfolio of "shovel-ready" projects totalling at least £1.5 billion, with the intention of attracting significant new private investment into the region by October 2021
- We will work with each of our partners to help strengthen their existing strategies, and seek ways of increasing the effectiveness of those strategies through collective regional working.

- In **October 2021,** just before the International Conference in Glasgow (COP 26) we will launch NEECCo's Regional Plan, setting out our progress so far, setting out ambitious targets for the region, and describing how we intend to meet and beat these targets. We will work together as a region to monitor our shared progress every year between now and 2030
- We will share examples of good practice across the region. Our website www.neecco.org.uk shows some initial examples we will build on this collection.
- We will engage in public debate on controversial issues such as carbon capture and storage, and changes to farming practice
- In **October 2021** we will use the COP 26 Conference to galvanise activity across the region on what we can do together to tackle the climate emergency.
